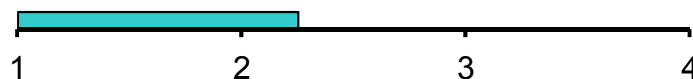

The information received in prior to the DFD was clear and informative



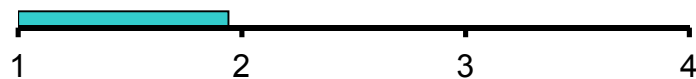

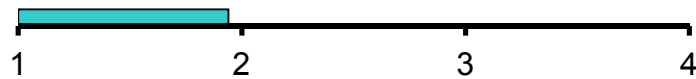

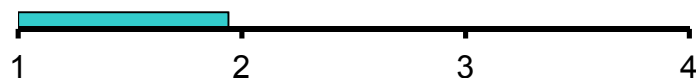

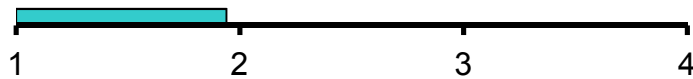
