The session introduced a selection of initiatives to illustrate the implementation of Priority Area 10. Thereby, a short video presented a variety of initiatives addressing the following thematic clusters: 1) Funding; 2) Civil Society & Local Actors; 3) Institutional Capacity. After each short video, a selection of initiatives was presented by the project partners, owners of the initiative.











Funding

The short video on "Funding" presented the following initiatives: EuroAccess MacroRegion, Bridging the Gap, Donors Conferences, and the Network of ESF Managing Authorities in the Danube Region.

Funding: Update from the Network of ESF Managing Authorities in the Danube Region

Barbara WILLSBERGER (Priority Area 9 "People & Skills", L&R Social Research) gave an overview of the work of the ESF managing authorities network so far and the future steps. The network aims at fostering transnational cooperation within the ESF+ Operational Programmes in the Danube Region, to thereby connect cooperation and investment, and serve as a joint knowledge hub for implementation, planning and exchange of experience with social policies. Ms Willsberger presented the current milestones in the embedding process in the ESF+ that the network has reached:

In the last years the focus was on the discussion of common topics of the Danube Strategy and the ESF national Operational Programmes. Further, the network discussed some common topics to address in transnational cooperation across the Danube Region. At this stage the network will discuss, which topics will be addressed by a cluster of Danube countries and which will be addressed throughout the Danube Region, such as social innovation.

Another relevant milestone is the discussion on a common text module. In 2020, the network developed a draft provision for the programmes.

An additional milestone is the successful project application for social innovation competence centres. The project is called Social Innovation Plus – Competence Centres (SI Plus) with partners from Slovakia, Hungary, Bulgaria and Austria as lead partner but also associated partners from Baden-Württemberg, Croatia and Slovenia.

Further, Ms Willsberger explained the next step for the ESF network and the embedding process: the next meeting is expected to take place on the 1st of June and will continue the exchange on common topics and the text module. Furthermore, the meeting is supposed to launch a discussion on the implementation of future transnational projects. (More information please find here)

Funding: Bridging the gap

Jernej GRAHOR (PAC 10/Centre for European Perspective), presented the "bridging the gap" initiative, a platform that aims at providing an opportunity for the cooperation and exchange of ideas for previous and new stakeholders within the EUSDR from the public administration, private sector and civil society. The project will provide a technical solution for the stakeholders to exchange their ideas, networks and projects, like e.g. a website or an app where they can share their ideas as well as experts meetings and policy recommendations. It will be an opportunity for different stakeholders (civil society, youth, decision makers,...) to cooperate.

Civil Society & local actors: MELIA Observatory

Erika URSIC (School of Advanced Studies, Nova Gorica) presented the MELIA Observatory project, whose main objective is to promote sustainable democracies by developing a transnational media literacy observatory, based on cooperation between different relevant stakeholders. In many countries of the Danube region, the development of competencies of media literacy and active citizenship is lacking behind. This observatory will serve as a mechanism for increasing media literacy and thus strengthening citizens' competencies what will contribute to the development of sustainable democracy. The main target groups are young people and the people who work with them. Against this background, the observatory will provide tools, available for both young people as well as their educators.

The project will establish an observatory for media literacy that will provide instruments for scrutinizing media contents, training tools and policy recommendations for upgrading media literacy in relation to other civic skills.

Shoot by Youth

Lyuben GEORGIEV (Re-Act/Danube Youth Network) presented the Shoot by Youth project, a video competition for young people engaging in local participation. A team of youth organisation representatives from 5 countries are developing the competition. Teams of young people between 15-25 years can take part. The videos should show a local challenge/ problem and a possible solution. Each winning team will receive a micro grant to realize the idea presented in the movie. Further, the top three winning teams will win money (250-500 €) and the winning videos will be shown to the public.

Annex VII Shoot by Youth

Civil Society & local actors: TalentMagnet

Ana NOVAK (Centre for European Perspective) presented "TalentMagnet", a project with 29 partners in 12 counties that aims at strengthening local institutional capacities to mitigate brain-drain and to help medium-sized cities in the Danube region to develop tools to reduce the outmigration of talented young workforce. It is not just about opening up attractive job opportunities, but about improving the quality of life in a broader sense. The focus of the project is expressed through the fact that most of the project partners are municipalities, development agencies and NGOs. The main result is to establish new multilevel and transnational governance model/tools/plans for talent attraction and retention.

Civil Society & local actors: National Participation Day

Stefan LÜTGENAU (Danube Civil Society Forum) reported on the biggest challenges for the National Participation Day format in 2021. As, due to the COVID 19 crises, all 5 National Participation Days planned for 2020 had to be cancelled. Hence, we need to create a new format that takes into account the present conditions. Unfortunately, participation turned out to be very challenging for many organisations in an online meeting format. Therefore, it is all the more important to think of how to make better use of digital formats at national and regional level as well as how to adapt the format to the respective national/regional needs of countries. Additionally, the National Participation Days are not following a "one size model fits all"-model as the region covers various political landscape and various forms of political culture, particularly regarding communication and exchange between state and non-state stakeholders. From the point of view of the civil society organisations, the digital meetings should be incorporated and we should organise meetings with former and future organizers to brainstorm and discuss potential formats for National Participation Days











that are tailor-made fit to the needs and situations in the respective regions and countries. Finally, Stefan LÜTGENAU pointed out that with regard to National Participation Days, the national stakeholders are the crucial drivers. However, the DCSF is at their disposal for support.



Priorities of the Slovak EUSDR Presidency in 2021

Michal BLASKO (National Coordinator of the EUSDR, Ministry of Investments, Regional Development and Information, SK) presented the priorities of the EUSDR Slovak presidency based on current challenges. He also presented what has been achieved in the past and what is planned for the future. Further, Mr. Blasko highlighted the 10th Annual Forum on 26-27 October 2021, which will take place in a hybrid format. The title of the Annual Forum 2021 is: "Green and Digital Transformation: A Route to a Prosperous Danube Region". Additionally, he pointed out the importance of the embedding process and underlined the importance of better involvement of non-EU member states.

- the EUSDR Intranet as well as

Karolina JASINSKA-MÜHLECK (DG Regio/ Unit D.1, European Commission) highlighted 3 initiatives particularly relevant for EUSDR PA10

Youth Manifesto (and the ECs follow up actions)

The Youth Manifesto presents young people's ideas on Interreg and especially on how to make it more in line with their expectations. It is mainly addressed to policy makers at EU, national, regional and local level as well as to Interreg Managing Authorities and project beneficiaries, organisations interested in EU cohesion – and especially Interreg – policy making, youth, citizens' engagement and democratic participation.

The ideas presented in the manifesto have been collected by European Commission via targeted surveys, polls and online group discussions with young people from all over Europe (i.e. EU, outermost regions and its neighbouring countries).

Ms Jasinska-Mühleck pointed out that the EC offers structure and support - amongst others - through meetings of a core group to facilitate exchanges and stimulate joint ideas. (https://www.linkedin.com/groups/13908870)

Further, she underlined the ECs willingness to help to promote any initiative in terms of youth involvement. Concerning the framework to boost and enable youth involvement, Ms Jasinska-Mühleck recommended to











think about the structural approach towards youth involvement on all levels of the Danube Strategy's governance.

What can we expect from the Danube Transnational Programme II?

Johannes GABRIEL (Danube Transnational Programme) presented the key elements and current programming processes of the Danube Transnational Programme 2021-2027. The thematic scope of the DTP II will address: innovation, environment and energy, social affairs and tourism and governance and EUSDR support. He pointed out, that projects dealing with PA10 topics (as PA10 has also horizontal scope), might be covered by all the priorities.

He announced that the first call, which will be a 2-step call, will be launched together with the kick-off event in October 2021.
